Background:	<p>Oral information on meetings and relevant activities since last Plenary, namely:</p> <ul style="list-style-type: none"> - Contact Network (Benchmark) Meeting in Cologne with Detecon hosting, INTT chairing and CMT presenting the Benchmark Report 2015. - Plenary Meeting in Sharm El Sheik hosted by NTRA decided about work program - 1st Expert Workshop hosted by NTRA in Cairo about “Licensing and Auctioning” had to be postponed to 2017 due to lack of participation of EU members. Now planned for 2nd half of April 2017 in Cologne. - 2nd Expert Workshop hosted by ANACOM in Lisbon about “Internet of Things” was attended by 24 participants from 12 countries. - 3rd common EMERG/BEREC Expert Workshop hosted by BEREC in Brussels about “Regulation of Voice” was attended by 29 participants from 20 countries. - 4th Expert Workshop hosted by AGCOM in Rome about “Net Neutrality” was attended by 28 participants from 14 countries. -

3.2 Implementation of the Work plan 2016 and recommendations

Title	Status of the 2016 Annual Report
Document	Oral presentation
Background:	<p>The 2016 EMERG Annual Report, has been prepared based on the results of the implementation of the EMERG Work Plan 2016, including recommendations. The final document will include brief reports from the workshops that took place in 2016, including the one that will be held in Cologne on 26 April on Licensing & Auctioning, that was part of the WP 2016.</p> <p>To this aim, the final report will be approved in a separate EMERG meeting besides the Summit with BEREC-Regulatel and EaP in Cascais or via electronic voting.</p> <p>At the CN, as a result of the Expert Workshops held in 2016, five recommendations out of seven have been recommended. After the presentation of the draft report and following the discussion, the CN agreed to pass to the Plenary 6 out of the 7 recommendations proposed for final approval. Namely:</p> <ol style="list-style-type: none"> 1. Internet of Things (IoT). Assess and agree on spectrum bands and wireless standards most appropriate for IoT uses in EMERG countries (Sigfox, Zigbee, 2G/3G/4G/5G, etc.). 2. Regulation of Voice. Address the benefits and the options for a harmonized regulation of international roaming prices and how to achieve it.



	<p>3. Regulation of Voice. Foster the harmonization of costing models for fixed (mobile) voice call termination among EMERG countries to bottom-up long-run incremental costs.</p> <p>4. Regulation of Voice. Evaluate and review of “price floor” regulation for international incoming voice traffic in EMERG member countries with level significantly above average.</p> <p>5. Net Neutrality. Design and shape suitable harmonized approaches (e.g., by means of common positions) about “zero rating” commercial practices.</p> <p>6. Net Neutrality. Assess and identify best practices for NRA evaluation tools (websites) allowing consumers to compare the performance of Internet access services, identify relevant traffic management measures and possible filtering and the cost of alternative usage patterns.</p> <p>The CN also agreed to propose to the Plenary to include the wholesale and retail roaming charges in the next Benchmark Report.</p>

5. EMERG 2017 External Institutional Activity

Title	Cooperation with BEREC

Background:	<p>In April 2014, EMERG and BEREC signed a Memorandum of Understanding (MoU), which set the basis for the cooperation between both platforms of regulators. Information will be provided about the activities which are going to be carried out this year under this framework of cooperation, mainly the organization of a joint working group and the celebration of an annual Summit BEREC – EMERG.</p> <p>At the CN ANACOM, as host of the event, informed that, according to schedule, on 31 May 2017, the next BEREC-EMERG Summit will take place in Cascais (Portugal), in a joint event with Regulatel and the EaPeReg, as in 2015.</p> <p>Furthermore, it has been mentioned that apart from the issue of the Summit, the MoU with BEREC also foresees that, at least, one joint workshop shall be organized</p>



	during the current year. On this, contacts shall be coordinated with the CNMC, once the EMERG WP for 2017 is approved.

Background:	At the CN DETECON presented first ideas for the benefit of EMERG to non-EU members and possible organizational options for self-financing. In particular, DETECON illustrated 2 options: Financing a permanent OR a virtual organization, stressing the benefits of each.

Background:	<p>The European Commission committed to fund up to 4 workshops in 2017 within the new NAPT Program. EMERG shall decide on the subjects to be included in the draft 2017 EMERG Work Plan for these workshops, based on the results of the consultation made among the EMERG members (15 February 2017) and following the discussion at the CN.</p> <p>As a second step, the CN decided to merge the initial 18 topics into 9 and finally to prioritise them with an expression of interest. With the purpose to share as much as possible the WP for 2017, including topics of common interest, the Chair proposed to give a further opportunity the Members, not at the CN, to express their preferences in a short commenting round after the CN.</p> <p>The current version of the WP is the final outcome of the above mentioned procedure and include the following topics for the Expert Workshops 2017, bearing in mind that one of them will be organised in cooperation with BEREC:</p> <ol style="list-style-type: none"> 1. Broadband strategies and Universal Service; 2. OTT Regulation, Cross Border content portability Big Data Regulation and Key market indicators; 3. NGN and Network Sharing and LLU; 4. Quality of Service and Consumer protection. <p>The Chair at the CN and in a following call for volunteers (deadline 10 March 2017) asked for the availability to chair or to host one of the planned workshops.</p>
Action required:	To approve the draft 2017 EMERG Work Plan and to publish it on the website.
